It is in the best interest of Acme Happenings to provide the highest quality bartender service. Acme Happenings policy and state law prohibits service of alcohol to minors and to people who are visibly intoxicated. Acme Happenings employees are required by company policy and by state law to request valid, state issued ID from anyone they deem to appear below the age of 21 and will refuse service to anyone unable to present valid ID.

Though Acme Happenings will do everything to conform to these company policies, it must be understood that we cannot be held responsible for the behavior of your guests. Acme Happenings will not purchase or sell alcohol at your event. Acme Happenings only provides for the serving of **your** alcohol. In the event that someone is injured at your event due to their consumption of alcohol, sole responsibility for that injury falls to you and ultimately to the intoxicated person who caused the injury.

Acme Happenings bartender services are limited to the states of Maryland and Virginia.

ALCOHOL WAIVER and RELEASE of LIABILITY FORM

ACME HAPPENINGS DOES NOT PROVIDE FOR THE SERVING OF ALCOHOL AT THE EVENT UNLESS THIS LEGALLY BINDING RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT IS SIGNED. ACME HAPPENINGS WILL NOT PURCHASE ALCOHOL FOR THE EVENT NOR SELL ALCOHOL AT THE EVENT.

I, the undersigned (Client) acknowledge that the serving of alcohol for my event carries potential risks and dangers beyond the control of Acme Happenings. I also acknowledge that though Maryland and Virginia do not have Social Host Liability or Dram Shop laws in place. I, as the responsible party, still assume all liability for myself and all event participants, invitees and other guests for any form of negligence that may arise from the consumption of alcohol by the event participants, invitees and other guests. I hereby agree to indemnify, defend, release, and hold harmless Acme Happenings, including the owner, members, agents and employees and families thereof (collectively "Releasees") from all liability to me, my invitees/guests, my next of kin, my conservators, assigns, heirs, guardians or other legal representatives for any and all claims, demands, losses or damages, suits, fines, including court costs and attorneys' fees, for any injury, death, or damaged property arising out of making available/serving alcohol at this event. I hereby waive all legal rights to pursue any form of legal action against Acme Happenings and the Releasees.

I HAVE READ THIS AGREEMENT AND HAVE SIGNED IT FREELY. I FULLY UNDERSTAND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT OF THE LAW.
